# Summit County RACES Registration Form

*(An addendum to the Summit County ARES registration form)*

Ohio Revised Code 5915.14 requires that each person who is appointed to serve in any position in emergency management (including RACES), before entering upon his/her duties, take an oath in writing. The oath shall be as follows:

"I, \_\_\_\_\_, do solemnly swear (or affirm) that I will support and defend the Constitution of the United States and the Constitution of the State of Ohio against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I will obey the orders of the Governor of the State of Ohio; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will faithfully discharge the duties upon which I'm about to enter."

"And I do further swear (or affirm) that I do not advocate, nor am I a member of any political party or organization that advocates the overthrow of the Government of the United States or of this State by force or violence; and that during such time as I am engaged in emergency management employment or activities, I will not advocate nor become a member of any political party or organization that advocates the overthrow of the Government of the United States or of this State by force or violence."
